REPLACE EXISTING OLD GYM DSC 4020 SECURITY ALARM MAIN CONTROL WITH A DSC 4204 POWER SUPPLY & DSC 4116 ZONE EXPANDER AND CONNECT THE MAIN BUILDING DSC 4020 SECURITY ALARM MAIN CONTROL PANEL VIA (2 4 CONDUCTOR 16 GAUGE NON-SHIELDED CABLES. USE EXISTING EMPTY 2 INCH CONDUITS BETWEEN THE OLD GYM & MAIN BUILDING. PROGRAM SECURITY SYSTEM AS NEEDED TO MAKE ONE WORKING SECURITY ALARM SYSTEM FOR THE ENTIRE CAMPUS. PROGRAM A SEPARATE PARTITION FOR THE OLD GYM.

- REPLACE EXISTING OLD GYM & FIELDHOUSE SILENT KNIGHT 5820XL FIRE ALARM MAIN CONTROL WITH A SILENT KNIGHT 5895XL POWER SUPPLY AND CONNECT TO THE MAIN BUILDING FIRE ALARM MAIN CONTROL PANEL VIA (2) CONDUCTOR 16 GAUGE NON-SHIELDED CABLES. USE EXISTING EMPTY 2 INCH CONDUITS BETWEEN THE OLD GYM & MAIN BUILDING. PROGRAM FIRE SYSTEM AS NEEDED TO MAKE ONE WORKING FIRE ALARM SYSTEM FOR THE ENTIRE CAMPUS.CONTRACTOR TO PROVIDE AND INSTALL ADDITIONAL SMOKE DETECTORS IN OLD GYMNASIUM BASKETBALL COURT
- PROJECT SCOPE INCLUDES A FULL FIRE ALARM SYSTEM REPLACEMENT AND UPGRADE FOR THE JUNIOR HIGH SCHOOL MAIN CAMPUS. REFERENCE SHEET SPECIFICATION ON SHEET T603 FOR ADDITIONAL INFORMATION.




