

GENERAL NOTES

- 1. FIRE: CONNECT NEW FIRE ALARM DEVICES TO NEW MAIN BUILDING SILENT KNIGHT FIRE ALARM SYSTEM. SUPPLY ALL POWER SUPPLIES NAC PANELS, ETC NEEDED. PLEASE SEE FIRE ALARM SPECIFICATIONS FOR PART NUMBERS AND SYSTEM REQUIREMENTS.
- 2. SECURITY: CONNECT NEW SECURITY ALARM DEVICES TO NEW DSC 4204 POWER SUPPLY AND DSC 4116 ZONE EXPANDER. CONNECT NEW DSC 4204 POWER SUPPLY AND DSC 4116 ZONE EXPANDER TO EXISTING MAIN BUILDING DSC 4020. CONNECT WITH 2-4 CONDUCTOR 16 GAUGE NON-SHIELDED CABLES. PROGRAM AS NEEDED TO COMPLETE CONNECTION.
- DATA: CONNECT NEW DATA, WIFI AND CAMERA NETWORK DROPS TO NEW IDF. CONNECT NEW IDF TO EXISTING MAIN BUILDING MDF VIA FIBER AND CAT 6. SEE NETWORK SPECS FOR FIBER AND CAT 6 INFO.
- . INTERCOM: CONNECT NEW INTERCOM DEVICES TO EXISTING TELECOR SYSTEM. PROVIDE TELECOR CLOCK DRIVER AS NEEDED.
- 5. CLOCK: CONNECT NEW CLOCK DEVICES TO EXISTING TELECOR SYSTEM. PROVIDE TELECOR CLOCK DRIVER AS NEEDED.
- 3. ACCESS CONTROL: CONNECT NEW ACCESS CONTROL DEVICES TO NEW KEYSCAN CONTROLLER.
- 7. CAMERAS: CONNECT NEW CAMERAS TO NEW IDF. SEE CAMERA SPECIFICATIONS FOR MOUNTING LOCATION.

- B. A LICENSED FIRE ALARM PLANNING SUPERINTENDENT CERTIFIED TO A MINIMUM LEVEL 3, IN THE SUBFIELD OF FIRE ALARM SYSTEMS THROUGH THE NATIONAL INSTITUTE FOR CERTIFICATION IN ENGINEERING TECHNOLOGIES (NICET), SHALL PROVIDE PLANS AND CALCULATIONS FOR A MANUAL AND AUTOMATIC FIRE DETECTION AND ALARM SYSTEM TO COMPLY WITH THE BUILDING SPACE LAYOUT, BUILDING OCCUPANCY, CURRENT NFPA 72, LOCAL AND STATE CODE REQUIREMENTS, AND THE FIRE ALARM AND DETECTION SYSTEM SPECIFICATIONS.
