





GENERAL NOTES

- INTERCOM: CONNECT NEW INTERCOM DEVICES TO EXISTING TELECOR SYSTEM. INTERCOM WIRE SHALL BE SHIELDED. CONTRACTOR TO PROVIDE EQUIPMENT WIRE AND SYSTEM PROGRAMING NEEDED. PROVIDE 4 EXTRA SHIELDED INTERCOM WIRES FOR FUTURE USE. PROVIDE ENOUGH SLACK TO REACH FURTHEST WALL.
- B. DATA: CONNECT ALL NEW DATA DROPS TO EXISTING MDF LOCATED IN MAIN BUILDING. PROVIDE 4 EXTRA CAT 6 CABLES FOR FUTURE USE. PROVIDE ENOUGH SLACK TO REACH FARTHEST WALL.
- SECURITY ALARM: CONNECT NEW SECURITY ALARM DEVICES TO EXISTING DSC SECURITY ALARM SYSTEM LOCATED IN MAIN BUILDING. ALL WIRING SHALL BE NON-SHIELDED. CONTRACTOR TO PROVIDE ALL EQUIPMENT, WIRE AND SYSTEM PROGRAMMING NEEDED.
- FIRE ALARM: CONNECT NEW FIRE ALARM DEVICES TO EXISTING SILENT KNIGHT FIRE ALARM SYSTEM LOCATED IN MAIN BUILDING. CONTRACTOR TO PROVIDE ALL EQUIPMENT, WIRE AND SYSTEM PROGRAMMING NEEDED.
- CLOCK: CLOCK SHALL BE STAND ALONE 110V CLOCK AMERICAN TIME MODEL E56BAAV304

KEYED NOTES

- 1 CONTRACTOR TO PROVIDE AND INSTALL 4-2" AND 1-1" UNDERGROUND CONDUITS FROM SAFE ROOM IDF TO EXTERIOR OF EXISTING BUILDING AS INDICATED. CONDUITS SHALL BE DEDICATED AS FOLLOWS:
 - 1-2" FOR DATA 1-2" FOR INTERCOM
 - 1-2" FOR SECURITY
 - 1-2" FOR SPARE 1-1" FOR FIRE
- 2 INDICATES THE LOCATION WHERE THE UNDERGROUND CONDUITS SHALL STUB UP EXTERIOR WALL AND INTO THE PLENUM SPACE OF THE EXISTING BUILDING. CONDUITS SHALL BE SECURED TO BUILDING STRUCTURE. ALL PENETRATIONS SHALL BE PROPERLY SEALED.
- 3 INDICATED APPROXIMATE ROUTE OF ABOVE CEILING. NO WIRING CABLING SHALL BE EXPOSED.
- 4 APPROXIMATE LOCATION OF EXISTING MDF.
- 5 APPROXIMATE LOCATION OF EXISTING IDF.
- 6 APPROXIMATE LOCATION OF EXISTING FACP, INTERCOM HEAD END UNIT AND SECURITY ALARM MAIN CONTROL UNIT.
